RESOLUTION NUMBER R- 262276

ADOPTED ON JAN 22 1985

WHEREAS, the Intergovernmental Relations Department (IRD) requested the various departments of the City, by memorandum dated August 14, 1984, to submit proposals for inclusion in The City of San Diego's 1985 Legislative Sponsorship Program; and

WHEREAS, on December 12, 1984, the Public Services and Safety (PS&S) Committee reviewed and approved the two legislative proposals described in IRD Report Nos. 84-72 and 84-73, both dated November 19, 1984, relating to law enforcement, and took no action on the legislative proposal described in IRD Report No. 84-71 relating to ARJIS funding but directed staff to determine the interest of the new Board of Supervisors in allocating a fair share of AB 189 funds to ARJIS; and

WHEREAS, on January 14, 1985, the Rules Committee also reviewed the three proposals previously considered by the PS&S Committee and a legislative proposal regarding enforcement of local zoning ordinances as described in IRD Report No. 84-77, dated December 3, 1984, and a proposal regarding railroad crossings as described in IRD Report No. 85-2, dated January 7, 1985; and

WHEREAS, the Rules Committee confirmed the action of the PS&S Committee on IRD Report Nos. 84-71, 84-72 and 84-73 and approved IRD Report Nos. 84-77 and 85-2; and


WHEREAS, the Rules Committee, on January 14, 1985, also took action to direct staff of the Intergovernmental Relations Department to support the County of San Diego's legislative proposals relating to mental health, drug and alcohol funding; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the legislative proposals described in IRD Report Nos. 84-72, 84-73, 84-77 and 85-2 be and the same are hereby approved for inclusion in The City of San Diego's 1985 Legislative Sponsorship Program.

BE IT FURTHER RESOLVED, that action on the ARJIS proposal described in IRD Report No. 84-71 is hereby deferred pending a determination of the County Board of Supervisors' interest in allocating a fair share of County AB 189 funds to ARJIS.

BE IT FURTHER RESOLVED, that the Intergovernmental Relations Department and the City's Sacramento Representative be and hereby are directed to support the County of San Diego in its efforts to secure legislation to provide equity in the State's funding of mental health, drug and alcohol programs.
