WHEREAS, Mission Pacific Associates, the developer and owner of the proposed hotel, the City Manager and City Attorney executed an agreement "Acknowledgement of Conditions and Responsibilities" (copy attached) to satisfy the above described contingency; and

WHEREAS, representatives of the State Department of Health Services have asked for some assurance that the Acknowledgement of Conditions and Responsibilities in fact satisfies the contingency contained in the resolution and requested that the Councilmembers who voted for Resolution No. R-261746 acknowledge the satisfaction of contingency; and

WHEREAS, this acknowledgement is required by the State

Department of Health Services before they will execute the

agreement with the City, and in order to allow the developer to

proceed with development of the Ramada Renaissance hotel; NOW,

THEREFORE,

BE IT RESOLVED, that the City Council hereby acknowledges that the attached agreement entitled "Acknowledgement of Conditions and Responsibilities" satisfies the contingency contained in the attached Resolution No. R-261746.

WHEREAS: The County of San Diego has assured the Department that it will oversee and monitor the activities of the City in order to protect public health and safety,

THEREFORE, it is agreed as follows:

The City agrees to assume full responsibility for any development of the Mission Bay Landfill site. The City further agrees to indemnify, release and forever save harmless the State Department of Health Services and its officers, agents and employees from and against any and all liability, loss,
