RESOLUTION NUMBER R- 262386

ADOPTED ON JAN 28 1985

WHEREAS, Public Law 09-396 allocated \$70,000,000 nationwide for an emergency food and shelter program to service needy individuals; and

WHEREAS, The City of San Diego was allocated \$273,660 of the total allocation to serve those needy individuals within the jurisdictional boundaries of The City of San Diego; and

WHEREAS, the program to serve these needy individuals was developed in large part by the voluntary effort of the community's social service agencies; and

WHEREAS, through the effort of the organization of social service agencies known as the Emergency Resource Group, hundreds of existing homeless individuals will be fed and sheltered during the winter months of 1985; and

WHEREAS, it is now appropriate to commend the efforts of the Emergency Resource Group for their efforts, which not only benefit the homeless, but the entire community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Emergency Resource Group, composed of San Diego social service representatives, is hereby recognized and commended for

its unselfish humanitarian effort in serving San Diego's homeless population.
