

RESOLUTION No. R-262390 (R-85-1031)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. ABABA BOLT, INC., 2. BUDCO BOLT, 3. FOREMOST THREAD PRODUCTS and 4. WESTERN FASTENER CO. are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing HARDWARE AND FASTENERS as may be required for the period of one (1) year beginning January 1, 1985 through December 31, 1985, per prices on file in the Purchasing Department as follows:

1. ABABA BOLT, INC. for Section I - Carriage Bolts; Section II - Nails; Section IV - Toggle Bolts and Lag Screws; terms net 30 days, with an option to renew contract for an additional one (1) year period, subject to a price escalation not to exceed 10% of prices in effect at the end of the initial contract year.
2. BUDCO BOLT - for Section V - Stainless Steel Cap Screws and Nuts; terms net 30 days, with an option to renew contract for an additional one (1) year period, subject to a price escalation not to exceed 30% of prices in effect at the end of the initial contract year.
3. FOREMOST THREAD PRODUCTS for Section III - Machine Screws; terms 1% 10 days, with an option to renew contract for an additional one (1) year period, subject to a price escalation not to exceed 10% of prices in effect at the end of the initial contract year.
4. WESTERN FASTENER CO. for Section VI - Other Fasteners (Will Call); terms 2% 10 days.
5. BUDCO BOLT - for Section VI - Other Fasteners (Will Call); terms net 30 days.
