
BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$772,500.00 from CIP No. 62-149 PACIFIC BEACH MASTER TRAFFIC SIGNAL CONTROL SYSTEM (\$767,000.00 from Gas Tax Fund 30219 and \$5,500.00 from Capital Outlay Fund 30245) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
