

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$57,000.00 from Gas Tax Fund 30219, CIP No. 62-232 DRAPER AVENUE AND PEARL STREET is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
