RESOLUTION NUMBER R- 262405

ADOPTED ON JAN 28 1985

BE IT RESOLVED, by the Council of The City of San Diego, that the period granted to the International Boundary and Water Commission (IBWC) is hereby extended, for operation of the emergency sewage regulating pond at the Tijuana River on a standby basis, until December 17, 1985, under the following conditions:

1. There will be no construction, operation or maintenance costs to the City of San Diego as a result of the emergency regulating pond.
2. IBWC will reimburse the City at the rate of \$431.17/mg for the cost of treating the sewage discharged from the emergency regulating pond to the Metro system.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to grant to IBWC during this period the number of days of pond usage deemed necessary.

BE IT FURTHER RESOLVED, that Resolution No. 262192, be and it is hereby rescinded.
