BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$24,000.00 from Fund No. 39005, CIP 58-028; CIP 58-044; CIP 58-050, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
