BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a ten (10) year lease agreement with PACTEL MOBILE ACCESS, a California corporation, for a 0.03-acre parcel of City-owned land on Aviation Drive, being an unused portion of the Encanto Standpipe, for the construction of a 145-foot antenna mast and a 572-square-foot equipment relay storage building, at an initial monthly rental of \$400, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 262409 .
