
RESOLUTION NUMBER R- 262414

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a First Amendment to Lease Agreement with MERZIOTIS PROPERTIES, INC., a California corporation, which First Amendment provides for expansion of lessee's restaurant facility at Brown Field from 2,180 square feet to 4,144 square feet, increases their annual minimum rent from \$3,000 to \$10,000 and extends the lease four (4) years, under the terms and conditions set forth in that First Amendment to Lease Agreement on file in the office of the City Clerk as Document No. RR- 262414.
