WHEREAS, it is necessary and desirable to procure professional legal services in conjunction with the Gaslamp Quarter Historic District Planned District Ordinance and Redevelopment Plan revision; and

WHEREAS, the firm of McDonough, Holland and Allen has been used as special counsel for the Gaslamp Quarter Redevelopment Project since the adoption of the Plan; and

WHEREAS, the Gaslamp Quarter Council recommends retention of that firm as Gaslamp Quarter special counsel; and

WHEREAS, a transfer of necessary funds to the Redevelopment Agency for the purpose of funding special legal counsel for the Gaslamp Quarter Project for the remainder of Fiscal Year 1985 is required; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$10,000 from the 1984 Gaslamp Quarter CDBG Project Fund 18520, Department 5817, Organization 1702 to the Redevelopment Agency, Fund 98340, for the sole and exclusive purpose of defraying costs of Special Counsel services.
