


RESOLUTION No. R-262435 (R-85-1256)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of CONTRACTORS EQUIPMENT CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE EACH 6 INCH TRASH PUMP, ENGINE AND TRAILER at a cost of \$10,514.48 for the pump and engine, and a cost of \$2,105.00 for the trailer, for a total cost of \$12,619.48; terms 5% 20 days, plus sales tax.
