
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one warrant check in the amount of \$75,000.00 made payable to "Lillian Pivar and Hyman Pivar, and their attorney of record, Charles S. Roseman," in full and final settlement of all claims and complaints.
