

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$198,000.00 from Revenue Sharing Fund 18013, CIP No. 52-323 MARGERUM AVENUE is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
