

1. That the City Manager be and he is hereby authorized and empowered to pay the total sum of \$137,787.84 in settlement of each and every claim against the City, its agents and employees, resulting from the personal injuries to Celia Cabbage and Donald G. Cabbage, a minor, by Celia Cabbage, his Guardian ad Litem. (Cabbage v. The City of San Diego, Superior Court No. 489803).

2. That the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$82,672.70, made payable to Celia Cabbage and her Attorney, James K. Eckmann, a professional law corporation; one check in the amount of \$19,115.14, made payable to James K. Eckmann, a professional law corporation; one check in the amount of \$35,000.00, made payable to the Executive Life Insurance Company of New York; and one check in the amount of \$1,000.00, made payable to the First Executive Corporation in full settlement of all claims.
