
RESOLUTION NUMBER R- 262480

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of an amount not to exceed \$640,000 from 1983 Community Development Block Grant Fund No. 18519 and an amount not to exceed \$195,240 from 1985 Community Development Block Grant Fund No. 18521, said expenditure being specifically contingent on funding approval by the Federal Department of Housing and Urban Development, to cover the cost of acquisition of right-of-way for the Amended Urban Design Plan for San Ysidro Boulevard, I-805 to Via de San Ysidro, is hereby authorized solely and exclusively for the purpose of providing funds for the above project.
