A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SUBMISSION OF A LETTER OF INTENT TO APPLY FOR THE 1986 TEST PROGRAM OF SUPPORT FOR LOCAL ARTS AGENCIES GRANT PROGRAM OF THE NATIONAL ENDOWMENT FOR THE ARTS (NEA); DESIGNATING COMBO AS THE CITY'S AGENT IN MAKING THE APPLICATION FOR FEDERAL ARTS GRANT.

WHEREAS, the National Endowment for the Arts (NEA) has established a Test Program of Support for Local Arts Agencies grant program designed to:

- 1. Promote increased and sustained funding, with public dollars, at the state and local levels;
- 2. Encourage joint planning among state arts agencies, local arts agencies, artists, arts organizations, and public officials: and
- 3. Elicit a variety of imaginative proposals and provide funding for projects that might serve as models to other states and communities; and

WHEREAS, the NEA is an independent agency of the federal government which was established in 1965 by federal law; and

WHEREAS, on January 28, 1985, COMBO appeared before the Rules Committee with a request that the City Council prepare a resolution designating COMBO as the City's agent in applying for a major grant from the National Endowment for the Arts (NEA); and

WHEREAS, NEA requires that the City's agent be authorized by the City to submit a letter of intent on or before February 15, 1985; and

WHEREAS, it is now deemed desirable to assign responsibility to an appropriate agency to prepare a letter of intent on behalf of The City of San Diego to apply for the Test Program of Support for Local Arts Agencies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that COMBO be and it is hereby designated as the City's agent in making the application for federal arts grant.

BE IT FURTHER RESOLVED, that the City authorizes COMBO to submit a letter of intent to participate in the 1986 Test Program of Support for Local Arts Agencies, without comment on the content of the project(s) proposed at this time.
