

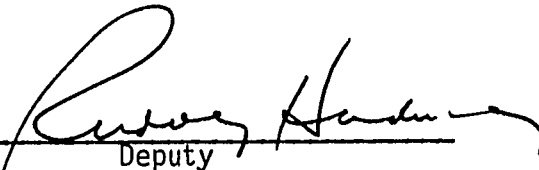
RESOLUTION No. R- 262510 (R-85-1351)
