BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. SOUTHWEST SAFETY & SUPPLY, 2. EXPORT MARKETING SERVICES (EMS), 3. MYERS EQUIPMENT CO. and 4. TUNA MARINE SUPPLY CO. INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of RAINGEAR AND BOOTS as may be required for a one (1) year period beginning February 1, 1985 through January 31, 1986, per prices on file in the Purchasing Department as follows:

1. SOUTHWEST SAFETY & SUPPLY for Section I; terms net 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period, price increases not to exceed 10% of original year prices.
2. EXPORT MARKETING SERVICES (EMS) for Section II; terms net 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period, price increases not to exceed 8% of original year prices.
3. MYERS EQUIPMENT CO. for Sections III, IV, and VI; terms net 30 days, plus sales tax.
4. TUNA MARINE SUPPLY CO. INC. for Section V; terms net 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period, price increases not to exceed 8% of original year prices.
