BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

SAN DIEGO MISSION ROAD CULVERT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$328,000.00 from CIP No. 12-050 SAN DIEGO MISSION ROAD CULVERT (\$15,000.00 from Capital Outlay Fund 30245 and \$313,000.00 from Revenue Sharing Fund 18013) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
