WHEREAS, the City Manager has reported that three-hour parking restriction has been effective; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the three-hour parking restrictions as described in Resolution No. R-260872 are hereby retained and the City Manager is directed to continue the current enforcement thereof.
