RESOLUTION NUMBER R- 262552

ADOPTED ON FEB 19 1985

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to negotiate for the purchase of the Trolley Barn property at 1924 Adams Avenue on the following bases:

1. The purchase price shall be fair market value;
2. The City shall acquire immediate fee title rather than entering into a lease with option to purchase;
3. Funds for the acquisition are conceptually approved to come from the Special Litigation Liability Reserve Fund No. 65011, said Fund to be reimbursed from Fiscal Year 1985 unallocated revenues; and
4. The property if acquired shall be used as a neighborhood park and open space.
