

RESOLUTION No. R-262556 (R-85-1353)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. VISTA PAINT CORPORATION 2. FULLER O'BRIEN PAINT, 3. SINCLAIR PAINT COMPANY, and 4. GLIDDEN PAINT CO. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of PAINTS AND COATINGS as may be required for a period of one (1) year beginning March 1, 1985 through February 28, 1986, per prices on file in the Purchasing Department, as follows:

1. VISTA PAINT CORPORATION for Items 2 and 9; terms 2% 30 days, plus sales tax, with options to renew contract for two (2) additional one (1) year periods, with price increases not to exceed 7% for each option year.
2. FULLER O'BRIEN PAINT for Items 1, 3, 4, 5, and 6; terms 1% 10th prox., plus sales tax, with options to renew contract for two (2) additional one (1) year periods, with price increases not to exceed 8% for each option year.
3. SINCLAIR PAINT COMPANY for Item 7; terms 2% 10th prox., plus sales tax, with options to renew contract for two (2) additional one (1) year periods, with price increases not to exceed 3% the first option year and 5% the second option year.
4. GLIDDEN PAINT CO. for Item 8; terms 1% 30 days, plus sales tax, with options to renew contract for two (2) additional one (1) year periods, with price increases not to exceed 10% for each option year.
