- That the City Auditor and Comptroller is hereby authorized 4. to transfer \$15,000.00 from CIP No. 91-801.3 GENERAL REVENUE SHARING UNALLOCATED RESERVE to CIP No. 33-075.0 FIRE REPAIR FACILITY NO. I - TRUCK HOIST.
- That the expenditure, not to exceed \$68,000.00, from Revenue 5. Sharing Fund 18013, CIP No. 33-075.0 FIRE REPAIR FACILITY No. 1 - TRUCK HOIST is hereby authorized solely and exclusively for providing funds for said project and related costs and authorizing the City Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
