

**RESOLUTION No.** R-262560



BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the sole bid theretofore received on January 3, 1984, pursuant to publication of notice calling for bids on CONSTRUCTION OF FIRE REPAIR FACILITY #1 - TRUCK HOIST is hereby rejected; and
2. That the amended plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the CONSTRUCTION OF FIRE REPAIR FACILITY #1 - TRUCK HOIST filed in the Office of the City Clerk of the City of San Diego, California, on FEB 25 1985, and bearing official Document No. W.O. 118575, be, and the same are hereby approved and that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF FIRE REPAIR FACILITY #1 - TRUCK HOIST.
4. That the City Auditor and Comptroller is hereby authorized to transfer \$15,000.00 from CIP No. 91-801.3 GENERAL REVENUE SHARING UNALLOCATED RESERVE to CIP No. 33-075.0 FIRE REPAIR FACILITY NO. I - TRUCK HOIST.
5. That the expenditure, not to exceed \$68,000.00, from Revenue Sharing Fund 18013, CIP No. 33-075.0 FIRE REPAIR FACILITY No. 1 - TRUCK HOIST is hereby authorized solely and exclusively for providing funds for said project and related costs and authorizing the City Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
