BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF NORTH PARK COMMUNITY ADULT CENTER IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$37,500.00 within Park Service District Fund 11594 from CIP No. 23-296 NORTH PARK COMMUNITY PARK - IMPROVEMENTS to CIP No. 29-539 NORTH PARK COMMUNITY ADULT CENTER - IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$117,500.00 from CIP No. 29-539 NORTH PARK COMMUNITY ADULT CENTER - IMPROVEMENTS (\$37,500.00 from Park Service District Fund 11594, \$65,000.00 from Park Service District Fund 11590, and \$15,000.00 from Community Development Block Grant Fund 18516/5965 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
