
RESOLUTION NUMBER R- 262595

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a five-year lease agreement with PACIFIC SOUTHWEST REALTY COMPANY, whereby City leases approximately 3,000 square feet of office space on the ninth floor of Security Pacific Plaza, at an initial annual rent of \$48,600, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 262595 .

BE IT FURTHER RESOLVED, that the transfer of an amount not to exceed \$53,600 from the Water Revenue Fund 41502, Unallocated Reserve (70679) to the Water Operating Fund 41500, Services Administration Program (70611) is hereby authorized and approved.
