
ADOPTED ON FEB 25 1985

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$300,000 of 1985 Community Development Block Grant Fund 18521, Department 5834, Organization 3406 (Social Services), is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
