Frederick Gabbard	Library	\$220	Mr. Gabbard is an Intermediate Clerk in the Library/ Support Services division. He suggested using a 1-ply continuous form order slips. One year's experience has shown a savings of \$738. This a full award.
Ronald Landes	Water Utilities	\$160	Mr. Landes is a Water Plant Operator in the Utilities Water Quality division. He suggested turning off wash water pumps during backwash. This was considered to be a significant operational improvement.
Wesley Leighton	Fire	\$50	Mr. Leighton is a Fire Fighter in the Fire department. He suggested adding a hydrant spanner to standard high-rise equipment list. This was considered to be a significant safety improvement.
