Lucille Alexopoulous	Risk Management	\$50	Ms. Alexopoulous is a Claim Representative II in the Risk Management/Liability division. She suggested establishing a notification procedure for the Federal Government when Police Officers are injured on Task Force assignments. This is a partial award pending a 12-month review.
Norman Jones	Buildings	\$25	Mr. Jones is a Plumber in the Buildings department. He suggested relocating a garbage disposal control switch. This was considered to be a significant safety improvement.
Marilyn Davis	Streets	\$25	Ms. Davis was a Utility Worker I at the time of her suggestion. She suggested posting a warning sign on the back of every Streets maintenance vehicle that says "sudden and frequent stops." This was considered to be a significant safety improvement.
