## RESOLUTION NUMBER R- 262616

## ADOPTED ON FEB 2 6 1985

BE IT RESOLVED, by the Council of The City of San Diego, that Resolution No. R-262008, adopted November 20, 1984, is hereby amended as follows:

1. By modifying the third full paragraph on page 2 to read as follows:

BE IT FURTHER RESOLVED, that net proceeds from the sale of Site 106 (Parcel No. 1) currently earmarked for the Special Capital Outlay Trust Fund be allocated as follows: approximately \$570,253 to the Low Income Housing Capital Outlay Fund reserved for future Housing Commission purposes, and at least \$1,258,732 to the Capital Outlay Fund for development of Collier/Sunset Park.

2. By modifying the third full paragraph on page 3 to read as follows:

BE IT FURTHER RESOLVED, that proceeds from the future sale of the Mast Boulevard site shall be allocated 27.2% to the Capital Outlay Fund and 72.8% to the Low Income Housing Capital Outlay Fund or in such a manner as to accomplish the 50/50 split described hereinbelow.

- 3. The last paragraph on page 4 is deleted in its entirety.
- 4. That the following language is added at the end of said resolution:

BE IT FURTHER RESOLVED, that it is the intent of the City Council that there be a 50/50 split of proceeds from sales and leases between the City and the Housing Commission during the period Fiscal Year 1981-82 through Fiscal Year 1987-88.

BE IT FURTHER RESOLVED, that Collier/Sunset Park shall be developed with funds provided the City by the Housing Commission.

BE IT FURTHER RESOLVED, that the above described revenues over the above described period of time be split exactly 50/50 between the Housing Commission and City and that City staff are hereby directed to take all actions necessary to accomplish said exact 50/50 division of funds.
