RESOLUTION NUMBER R- 262621

ADOPTED ON FEB 26 1985

WHEREAS, the proposed Otay Mesa Reorganization encompasses the geographic area addressed by Environmental Impact Report No. 84-0297 and Negative Declaration No. 84-0344; and

WHEREAS, by Resolution No. R-261533, which was adopted on September 11, 1984, the Council of The City of San Diego certified that the information contained in Environmental Impact Report No. 84-0297, in connection with the Otay International Center, had been completed in compliance with the California Environmental Quality Act of 1970, as amended, and the State guidelines thereto, and that said Report had been reviewed and considered by this Council; and

WHEREAS, by Resolution No. R-261537, which was adopted on September 11, 1984, pursuant to California Public Resources Code, Section 21081, the Council of The City of San Diego adopted findings made with respect to the feasibility of the mitigating measures and project alternatives and statements of overriding considerations for the Otay International Center; and

WHEREAS, by Resolution No. R-261532, which was adopted on September 11, 1984, the Council of The City of San Diego certified that the information contained in Negative Declaration No. 84-0344 had been completed in compliance with the California Environmental Quality Act of 1970, as amended, and the State guidelines thereto, and that said Negative Declaration had been reviewed and considered by this Council; and

WHEREAS, there are no new environmental issues relating to this reorganization that have not already been addressed by this Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the previous actions by this Council have satisfied the requirements of the California Environmental Quality Act as it pertains to the proposed Otay Mesa Reorganization.
