

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF SIDEWALK UNDERDRAINS AT AVIARY DRIVE, HEALTH CENTER ROAD, REGENTS ROAD AND GULLSTRAND STREET.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$38,000.00 from CIP No. 17-1001 ANNUAL ALLOCATION - MINOR DRAIN IMPROVEMENTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
