ADOPTED ON MARCH 4, 1985

WHEREAS, the new "Minority and Women Business Enterprise Program" and the revised "Equal Opportunity Program for non-Construction Contractors" have been developed pursuant to Council Policy 300-10 "Equal Opportunity"; and

WHEREAS, the object of these programs is to increase the participation of minority and women-owned business enterprises in the City's contract process; and


WHEREAS, these programs comply with the requirements of City Charter sections 35 and 94 which require the award of contracts through a competitive process to the lowest responsible bidder; and

WHEREAS, after public testimony and review, these programs were approved unanimously by the Rules Committee of the City Council on February 11, 1985; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council approves City Manager Report No. 85-37, dated January 23, 1985, a copy of which is on file in the office of the City Clerk as Document No. RR-262633, and, after full review adopts the staff recommendations contained in said Report No. 85-37 regarding the proposed Minority and Women Business

Enterprise Program and recommended changes to Equal Opportunity  
Program for non-Construction Contractors doing business with The  
City of San Diego.
