RESOLUTION NUMBER R- 262635

ADOPTED ON MAR 4 1985

WHEREAS, on February 6, 1984, Mayor Hedgecock convened the Growth Management Review Task Force (GMRTF) and charged it with responding to three principal questions:

1. How well has the City met the goals of its Growth Management Plan?
2. Can the Plan successfully accommodate future growth?
3. Can City facilities and services keep pace with projected growth?

and;

WHEREAS, on December 10, 1984, the Task Force presented its final report including some ninety-one recommendations, to the Council and the Council then directed the Rules Committee to submit a work program and recommendations to the various Council committees and City departments for their review and, subsequently, to the full Council; and

WHEREAS, it is now appropriate for the City Council to appoint, pursuant to Charter section 43(b), an Oversight Committee, temporary in nature, to provide assistance and advice to appropriate departments in respect to preparation of a work program for implementing the recommendations of the Growth Management Review Task Force; and

WHEREAS, background information and an analysis in regard to this matter is provided in City Planning Department Report No. 85-040, dated February 4, 1985, to the Rules Committee, said report prepared and approved jointly by the Planning Department and City Manager; and

WHEREAS, the Rules Committee (on February 11, 1985) considered said Report No. 85-040, the information and recommendations contained therein, and unanimously (5-0 vote) accepted the report and approved the recommendations; and

WHEREAS, it is now necessary to forward this matter to the full City Council for appropriate action upon the recommendations of the Rules Committee and those contained in the above-cited Report No. 85-040; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to Charter section 43(b), there is hereby created an Oversight Committee to provide assistance and advice to the appropriate City departments in respect to preparation of a work program for implementing the recommendations of the Growth Management Review Task Force.

BE IT FURTHER RESOLVED, that pursuant to the recommendation of and action by the Rules Committee, the Oversight Committee is
