WHEREAS, on February 25, 1985, the Rules Committee reviewed IRD Report No. 85-17, a joint report from the City Manager and the Intergovernmental Relations Department on Legislative proposals regarding school facility financing developed by the Ad Hoc School Facility Task Force; and

WHEREAS, the Rules Committee approved in concept the school facility financing legislative proposals described in IRD Report No. 85-17 and Attachments A, B, and C thereto; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the school facility financing legislative proposals described in IRD Report No. 85-17 and attachments thereto, be and the same are hereby supported in concept.

BE IT FURTHER RESOLVED, that Intergovernmental Relations Department and the City's Sacramento Representative be and they are hereby directed to seek introduction of said legislative proposals in legislation bill form in the State Legislature.


