ADOPTED ON MAR 5 1985

WHEREAS, on February 26, 1985, the Council of The City of San Diego heard the appeal of Tom and Cyndy Heath, et al, from the decision of the Planning Commission in approving proposed Tentative Map TM-82-0433.1 and Planned District Development Plan Permit No. 82-0433.1; at which hearing the matter of construction of a solid noise wall on Carmel Park Drive was continued to March 5, 1985; and

WHEREAS, on March 5, 1985, the Council of The City of San Diego heard the matter of construction by THE BALDWIN COMPANY of a solid noise wall on Carmel Park Drive, and voted 6 to 0 to require construction of such wall; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that THE BALDWIN COMPANY be, and it is hereby required to construct a solid noise wall on Carmel Park Drive, shown on Planning Department Exhibit "A" dated March 5, 1985, as set forth in paragraph 22 of Planned District Development Plan Permit No. 84-0433.1.
