BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the bids of 1. O. M. SCOTT & SONS COMPANY (aka Scott's Pro-Turf), 2. BUTLER'S MILL INC., 3. TARGET CHEMICAL CO., 4. ROBINSON FERTILIZER COMPANY, 5. MOYER CHEMICAL COMPANY, 6. WILBUR-ELLIS COMPANY and 7. LESCO, INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of FERTILIZERS, PESTICIDES, AND HERBICIDES, ETC. as may be required for a one (1) year period beginning February 1, 1985 through January 31, 1986, per prices on file in the Purchasing Department, as follows:

1. O. M. SCOTT & SONS COMPANY (aka Scott's Pro-Turf) for Items 21, 22, and 24; terms net 30 days, plus sales tax.
2. BUTLER'S MILL INC. for Items 1, 2, 6, 7, 8, 11, 27, 35, 36, 44, 49, 65 and 70; terms net 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period.
3. TARGET CHEMICAL CO. for Items 3, 17, 28, 29, 30, 31, 37, 43, 45, 46, 50, 59, 61, 64, and 66; terms 2% 30 days, net 31 days (net 25th prox. for Item 50), plus sales tax, with an option to renew contract for an additional one (1) year period.
4. ROBINSON FERTILIZER COMPANY for Items 4, 5, and 52; terms 2% 30 days, plus sales tax, subject to a potential price increase not to exceed 5% of the bid price during the initial contract period, with an option to renew contract for an additional one (1) year period.
5. MOYER CHEMICAL COMPANY for Items 9, 10, 14, 19, 25, 26, 38, 39, 40, 41, 42, 47, 48, 53, 54, 55, 58, 60, 62, 63, and 69; terms 2% 10 days, plus sales tax, subject to a potential price increase not to exceed 5% of the bid price during the initial contract period, with an option to renew contract for an additional one (1) year period.
6. WILBUR-ELLIS COMPANY for Items 12, 13, 15, 16, 18, 20, 23, 32, 33, 34, 51, 56, 57, and 68; terms net 10th prox., subject to a potential price increase not to exceed 5% of the bid price during the initial contract period, with an option to renew contract for an additional one (1) year period.
