APPROVING MAP OF BERNARDO HEIGHTS - UNIT NO. 17

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Norbert Rudolph Hamelchle, a licensed land surveyor, entitled "BERNARDO HEIGHTS - UNIT NO. 17, being a subdivision of a portion of Parcel 3 of Parcel Map No.13239, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, April 19, 1984 as File No. 84-144561 of Official Records," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Avenida Venusto, Avenida Sivrita, Calle Parral, Via Penoles, Calle Saucillo and Tetillas Court, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Camino Del Norte, adjacent and contiguous to Parcel "A," Lots 106 and 107, all as shown on this map within this subdivision.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for pedestrian and non-motor vehicular purposes, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for open space over, under, upon and across Lots 106, 107, 3, 28, 108 and Parcel "A," as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, as well as the easements for pedestrian and non-motor vehicular purposes and the open space easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
