That the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$50,000.00 made payable to Debra Aston individually and as Guardian ad Litem of Joseph Aston and William Thomas Aston and their attorneys, Luce, Forward, Hamilton & Scripps, in full settlement of all claims.
