That the City Manager be and he is hereby authorized and empowered to pay the total sum of \$50,000.00 in settlement of Superior Court Case No. 497438 (consolidated with No. 497436), Patricia Rae Preston v. T'NT Development, et al and of each and every claim against the City, its agents and employees, resulting from the death of Steven Alan Preston.

2. That the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$50,000.00 made payable to Patricia Rae Preston individually and as Guardian ad Litem of Ryan Alan Preston and their attorneys, Luce, Forward, Hamilton & Scripps, in full settlement of all claims.
