
ADOPTED ON MAR 11 1985

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$52,223.65 from the project contingency reserve available in the Industrial Development Fund 30248, CIP 39-040, Pueblo Lands Development, be and the same is hereby authorized solely and exclusively for the above purpose.
