WHEREAS, the City Council of The City of San Diego has committed itself to reducing the incidence of alcohol and drug abuse by young people; and

WHEREAS, Californians for Drug-Free Youth is recognized as the first state network and resource center established and funded by parents; and

WHEREAS, Californians for Drug-Free Youth is holding its third state-wide conference in San Diego, California on March 15-16, 1985; and

WHEREAS, the conference is expected to draw 650 adults and 200 teens; and

WHEREAS, workshops have been designed for young people to encourage maximum student discussion of issues such as drug pharmacology, adolescent suicide, youth gangs, and peer support programs; NOW, THEREFORE,

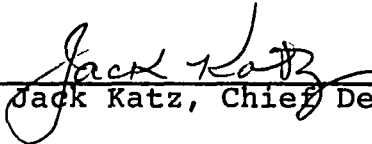
BE IT RESOLVED, by the Council of The City of San Diego, that March 11-18, 1985 is proclaimed "Californians for Drug-Free Youth Week" in The City of San Diego.
