WHEREAS, the South Shores area in Mission Bay Park is located on the north side of the flood control channel between Sea World and Interstate 5; and

WHEREAS, it had been recommended and approved that improvements be made at South Shores in order to mitigate the impact due to loss of embayment at Sail Bay; and

WHEREAS, the matter is set forth in City Manager's Report No. 85-117, dated March 5, 1985, recommending acceleration of the construction of South Shores area as required to comply with conditions necessary to obtain a U.S. Army Corps of Engineer's 404 permit for proposed Sail Bay improvements; and

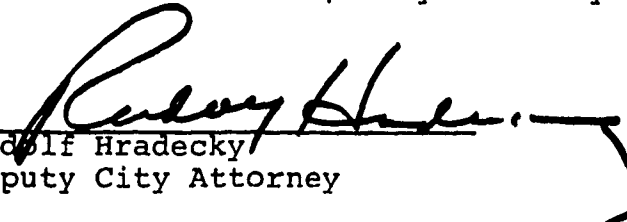
WHEREAS, on March 6, 1985, the Council Committee on Public Facilities & Recreation considered the information contained in City Manager's Report No. 85-117 and approved the recommendation therein, and now forwards the matter to the full Council for approval; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby directed to accelerate a project for the construction of a small bay in the South Shores area of Mission Bay Park, City of San Diego, as set forth and recommended in City Manager's Report No. 85-117, dated March 5,

1985, and to take the necessary steps to place this project into the Fiscal Year 1986 Capital Improvements Program.
