RESOLUTION NUMBER R- 262705

ADOPTED ON MAR 11 1985

WHEREAS, the California Arts Council and the California Legislature have established a State/Local Partnership Program designed to encourage local cultural planning and decision-making and to reach previously underserved constituents; and

WHEREAS, on March 11, 1985, the Rules Committee reviewed IRD Report No. 85-23, dated March 5, 1985, and recommendations contained therein regarding the California Arts Council's FY 1985-86 State/Local Partnership Grant Program; and

WHEREAS, the Rules Committee recommended that the City Council approve application to the California Arts Council (CAC) for a FY 1985-86 State/Local Partnership Program (S/LPP) Level One Grant in the amount of \$15,000, which grant does not require any local matching funds; and

WHEREAS, the Rules Committee further recommended that the City Council additionally approve application to the CAC for a \$2,000 S/LPP Incentive Grant and direct the City Manager to identify and allocate \$2,000 of City funds in the FY 1985-86 City Budget to be used as the required match for the S/LPP Incentive Grant; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, after review of the recommendations of the Rules Committee as described in IRD Report No. 85-23, dated March 5, 1985, does hereby approve participation in the FY 1985-86

State/Local Partnership Program established by the California Arts Council (CAC).


BE IT FURTHER RESOLVED, that the City Council be and it is hereby designated as the contractor with the CAC for purposes of participation in the FY 1985-86 State/Local Partnership Program.

BE IT FURTHER RESOLVED, that the Intergovernmental Relations Department be and it is hereby authorized to submit the application for the FY 1985-86 State/Local Partnership Program Level One Grant.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized, on behalf of the City, to execute the FY 1985-86 State/Local Partnership Program Level One Grant contract with the California Arts Council, contingent upon approval of the application by the California Arts Council, and that said grant contract shall be for both the \$15,000 unmatched CAC Level One Grant and the \$2,000 Incentive Grant.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to identify and allocate \$2,000 of City funds in the FY 1985-86 City Budget to be used as the dollar-for-dollar match required to receive the CAC Incentive Grant.
