RESOLUTION NUMBER R- 262710

ADOPTED ON MAR 12 1985

WHEREAS, on December 12, 1984, the City Council, at the recommendation of the Rules Committee, unanimously approved in concept the recommendations of the Final Report of the Mayor's Task Force on the Downtown Homeless; and

WHEREAS, one of these recommendations was that a Task Force be formed to coordinate the implementation of the service plan described in the Final Report; and

WHEREAS, during Council discussion, there was a stated concern that the private sector be involved in committing resources to this plan; and

WHEREAS, in line with this, the Mayor has requested the County of San Diego and the United Way join the City in developing the implementation phase recommended in the Final Report and both agencies have responded with commitments to participate; and

WHEREAS, in discussions with the co-sponsoring agencies, it has been recommended that five (5) additional members be appointed, said members to represent the business community (3), the private foundation community (1), and agencies providing services to the homeless (1); and

WHEREAS, the matter is now submitted to the full City Council to establish, pursuant to Charter section 43(b), a Regional Implementation Task Force on the Homeless, for the purpose of

addressing the issues indicated and providing a resolution to the charges set forth; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby establish, pursuant to Charter section 43(b), a Regional Implementation Task Force on the Homeless, to consist of membership as indicated.

BE IT FURTHER RESOLVED, that the membership of said Task Force shall be as follows:

BE IT FURTHER RESOLVED, that the responsibility and duties of the Task Force shall be as follows:


TASK FORCE MISSION STATEMENT

The Task Force will provide a central point for a coordinated regional approach by government, business and the private sector in addressing the challenge of the homeless in San Diego County. The Task Force will study and then implement feasible solutions that balance the needs of the homeless for services with the needs of the general community for protection and an improved economic and social environment.

CHARGE:

1. To identify and secure both public and private resources needed to implement viable programs to assist the homeless.
2. Develop and implement a coordinated approach to the planning and allocation of available funds.
3. Continue to refine our knowledge of the homeless and its various target populations.
4. Educate the public about the nature of the homeless.
5. Review the recommendations in the Mayor's Task Force on the Downtown Homeless Report, and other recent reports, and develop the resources to implement those recommendations where resources can be secured.
