BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of DE NARDI & WOOD is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of SIX (6) TRUCK BODIES, two (2) each Service and Maintenance Bodies at a cost of \$1,861.00 each, two (2) each Five Cubic Yard Dump Bodies with Hoists at a cost of \$4,318.00 each, one (1) each Twelve Foot Flatbed Dump Body with Hoist at a cost of \$2,056.00, and one (1) each Ten Foot Flatbed Dump Body with Hoist at a cost of \$2,010.00, for a total cost of \$16,424.00; terms 1% 20 days, plus sales tax.


