BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

CONSTRUCTION OF PARADISE MESA CROSSTIE PIPELINE.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$35,091.00 within the Water Revenue Fund 41502 from the Unallocated Reserve (70679) to the Water Main Construction Program (70592), CIP No. 73-232 PARADISE MESA CROSSTIE PIPELINE.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$5,298,191.00 from Water Revenue Fund 41502, CIP No. 73-232 PARADISE MESA CROSSTIE PIPELINE is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
