WHEREAS, AB 77 as introduced by Assemblyman Larry Stirling would provide the City of San Diego with a state grant of \$200,000 for purposes of restoring the Padre Dam in Mission Trails Regional Park; and

WHEREAS, Padre Dam, also known as Old Mission Dam, was designated a national historic landmark in 1964 due to its historical significance as California's first large-scale irrigation project having been built between 1813 and 1816 by native American Indians to serve the Mission San Diego de Alcala; and

WHEREAS, although the City of San Diego in January, 1985 hired a consultant to prepare a restoration/improvement plan for the Padre Dam and adjacent areas, the City has not identified funds for implementing this plan; and

WHEREAS, AB 77 would provide sufficient funds for the first phase of the restoration improvement project; and

WHEREAS, Councilman Murphy, the Parks and Recreation

Department and Intergovernmental Relations Department, in IRD

Report No. 85-19 dated February 19, 1985, have reviewed AB 77 and recommended to the Rules Committee that it be supported; and

WHEREAS, the Rules Committee now forwards the matter of AB 77 to the full Council with the recommendation to support; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, upon recommendation of the Rules Committee, and after review of IRD Report No. 85-19, dated February 19, 1985, does hereby express its support of AB 77 (Stirling) - State Funding For Preservation and Restoration of Padre Dam.
