ADOPTED ON MAR 18 1985

WHEREAS, legislation provides that 2% of Local Transportation Funds may be utilized for construction and operation of bicycle-pedestrian facilities; and


WHEREAS, those funds are placed in a single regional account and made available to cities and counties based on an area-wide priority list of such facilities approved annually by the SANDAG Board of Directors; and

WHEREAS, seven (7) claims for Local Transportation Funds (LTF) have been prepared for submittal to SANDAG which administers bikeway funding under the Transportation Development Act of 1971, all in accordance with Public Utilities Code sections 99233.3 and 99234; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered, for and on behalf of said City, to submit seven (7) claims to SANDAG and accept funds in the amount of \$1,542,800 in Local Transportation Funds for the following bikeway projects:

1. Sunset Cliffs Bridge Bikeway (\$970,000)
2. Black Mountain Road Bikeway (\$177,000)
3. Euclid Avenue Bikeway (\$10,500)
4. Genesee Avenue Bikeway (\$177,500)
5. Ingraham Street Bridge Bikeway (\$180,800)
6. Bicycle Storage Facilities (\$15,000)
7. San Diego Transit Bike Racks (\$12,000)
